Paper Requirements	About the Sponsors
<p>Submissions should be typewritten, double-spaced on 8 ½ x 11 inch paper. The paper shall not exceed 40 pages in length, including footnotes. Papers must include footnotes, not endnotes. Papers should be in 12pt.
