Cracks in the System: The Adequacy of the U.S. Healthcare Regulation in a Global Age

Imagine a pandemic arriving on our shores from a distant country. Imagine a bioterrorist attack that produces an infectious disease. Imagine a country in chaos. Is the United States equipped to handle these scenarios? Our nation's federal, state, and local regulatory responses to terrorist attacks and recent natural disasters do not tend to bolster confidence in this prospective scenario.

This Symposium will focus on the question of whether the United States has the regulatory structures in place to deal with a pandemic or biological terror attack. In addressing this question, the participants will explore the tensions between federal, state, and local regulation of different components of the health care system. Questions of federalism seriously complicated the coordination of relief efforts in the recent Hurricane Katrina disaster and raise concerns about what problems could arise should the nation face a pandemic or biological terrorist attack.

The first panel will identify already existing weaknesses in the current health care system that an emergency situation could exacerbate, and the second panel will focus more specifically on issues of public health preparedness in emergency situations.
