**WILLIAM SNAPE** and student Pascale Steverlynk (WCL '24), working with Patuxent Riverkeeper, successfully garnered a 1.1 million dollar civil penalty under the Clean Water Act against a corporate mobile home operator, who was allowing raw sewage and other contaminants into the Patuxent River. Professor Snape and the Program on Environmental and Energy Law co-hosted an event with the WCL Health Law Program entitled Climate Change & Health: Legal, Policy and Scientific Perspectives on October 9 with over 100 attendees. Representing the Center for Biological Diversity, Professor Snape successfully defeated a motion to dismiss by the Maryland Department of Natural Resources regarding a Public Information Act lawsuit seeking horseshoe crab take and mortality data relating to pharmaceutical companies' bleeding and killing of this important wildlife species.
