As the world's only trilingual (English, Portuguese, and Spanish) moot court competition on the Inter-American System, the Competition offers an exceptional opportunity for law students from across the globe to enhance their knowledge of International Law and Human Rights. As part of the Competition, participants engage in research, draft legal memoranda based on a hypothetical case, and present oral arguments before attorneys and leading figures in the human rights field acting as Judges of the Inter-American Court of Human Rights. The event aims to promote constant interaction between students, lawyers, professors, and professionals specializing in human rights worldwide. Over the years, the Competition has greatly contributed to strengthening human rights legal education, as well as establishing a network of engaged human rights professionals throughout the Americas and beyond.

### Important Dates

NOVEMBER 15 2024: Online registration opens.

DECEMBER 10, 2024: Hypothetical case available, in the celebration of Human Rights Day.

JANUARY 10, 2025: Publication of the Official Version of Hypothetical Case.

JANUARY 19, 2025: Deadline to request clarifications on the hypothetical case.

MARCH 12, 2025: Deadline for team registrations.

MARCH 25, 2025: Deadline for Team Memorials without penalties.

APRIL 11, 2025: Deadline for Observer registration.

APRIL 11, 2025: Deadline for Judges registration.

APRIL 11, 2025: Deadline for Bailiffs registration.

MAY 18, 2025: Opening Ceremony and competition check-in.

MAY 19-23, 2025: Oral rounds.



### How to take part



### Competitor

Current law students from around the world studying for a Juris Doctor (J.D) or its international equivalent are eligible to participate in 2-person teams representing their schools through written and oral arguments. Competitors participate in person.



### Coach

Each team may have 1 or 2 coaches, who are usually international law professors or attorneys with expertise in the field. Coaches assist teams with registration, fundraising, and obtaining official approval for their team's participation, as well as developing research strategies. Coaches participate in person during the Competition.



### **Judges**

Lawyers from various countries who have ample experience in international law and/or human rights contribute to the Competition as volunteer judges. They participate remotely by grading written memorials or by judging the Competition's oral rounds. Judges participate in person during the Competition.



### **Bailiff**

Anyone interested in receiving a front-row seat to the Competition's oral rounds is invited to participate in person as a bailiff. Bailiffs are responsible for keeping time and order during the 90-minute oral rounds.



### Observer

Deans, professors, and others affiliated with legal education or human rights law may attend in person as observers to learn about the Competition model, the Inter-American legal system, and issues surrounding the theme of that year. Observers may attend all Competition events, but do not present arguments.



### LL.M. In International Human Rights and Humanitarian Law





### Program of Advanced Studies on Human Rights and Humanitarian Law

The Program has gathered many participants from more than 20 countries with different levels of professional experience for an intensive 3 weeks of full immersion into the world of Human Rights. Participants can choose from 20+ courses in English and Spanish (All courses can be taken for ABA credit). The program provides the unique opportunity to learn and interact with judges of the International Court of Justice (ICJ), Special Rapporteurs and Committee members of the United Nations, members of the Inter-American Commission on Human Rights, experts from prominent NGOs and professors from all over the world. The Program takes place the week following the Inter-American Human Rights Moot Court Competition.
