“National Security Law and the Constitution”

Gary Corn and Jeffrey Kahn (3rd Edition)

National Security Law and the Constitution (3rd ed.) provides an in-depth, case-based treatment of the constitutional architecture underpinning U.S. national security powers. It explores executive, legislative, and judicial roles in domains such as war powers, intelligence, surveillance, domestic emergencies, and national security information, while attending to cross-cutting international law constraints. Ultimately, the text advances the view that U.S. national security law is fundamentally constrained by the Constitution and that legal oversight is essential to reconcile security demands with individual rights.

Claudio Grossman

La experiencia de transformación constitucional en Chile: distintas perspectivas (The Chilean Constitutional Experience) brings together leading scholars from Chile, Canada, Mexico, and Spain to analyze Chile's evolving constitutional process. The essays explore key themes such as separation of powers, social rights, environmental protection, the incorporation of international human rights treaties, presidential-congressional relations, and democratic legitimacy.



“Furthering Interests Abroad: Advancing Trademark Rights in the Americas in the First Decades of the Twentieth Century”

Christine Farley in The Silent Peacemaker: Intellectual Property Rights and the Interwar International Legal Order, 1919–1939 (2025)

This chapter explores the 1929 General Inter-American Convention for Trademarks and Commercial Protection as an early attempt to strengthen trademark and unfair competition protections across the Americas. It examines how the Convention introduced innovative legal standards that at the time surpassed many global norms. The chapter highlights the Convention's continued relevance as a binding international agreement that predates modern IP frameworks and offers an alternative model for regional cooperation. Though often overlooked, it presents a historically significant and still-valid legal foundation for protecting trademark rights in the Americas.



“Casebook on Chinese Outbound Investment: Law, Policy, and Business”

Matthew Erie (2025)

A Casebook on Chinese Outbound Investment: Law, Policy, and Business presents fifteen case studies examining how Chinese firms invest abroad, focusing on governance, structure, and accountability. Drawing on primary sources, including contracts, regulations, court decisions, and interviews, the book analyzes how Chinese investments adapt to different legal and political environments. It explores interactions with host states, the Chinese government, and local communities, highlighting legal, social, and environmental impacts. Designed for students and practitioners, the book offers structured case materials and discussion tools to support teaching and research on Chinese outbound investment.



“The Italian Influence on EU Law: Judges and Advocates General 1952-2000”

Fernanda Nicola (2024)

Drawing on perspectives from the judiciary, legal practice, and academia, this book examines Italy's role in shaping European Union law. It analyzes the judicial careers of Italian judges and advocates general over nearly five decades to highlight their influence on the EU's legal development. The book explores how these officials balance national connections with the principle of judicial independence. It provides insight into the ongoing relationship between EU judges and their home governments within the framework of the Court of Justice's rule of law.



“Advocating Social Change through International Law”

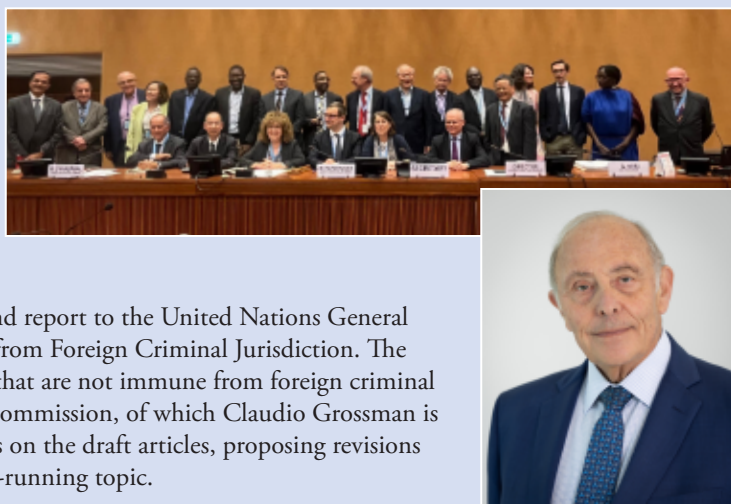
David Hunter (2nd Edition)

Advocating Social Change through International Law examines hard and soft international law through the social change lens. Through case studies on human rights, international crimes, environmental protection, public health, and financial regulation, the book analyzes state and non-state actors' strategic choices in using international law to advocate for social change. It highlights how different contexts shape the costs, benefits, and effectiveness of hard versus soft legal approaches. The volume offers new insights into the interaction between these forms of international law in driving social change.

Global Impact on International Law

Claudio Grossman Presented Report as Special Rapporteur on the Immunity of State Officials from Foreign Criminal Jurisdiction

Dean Emeritus and Professor Claudio Grossman presented his second report to the United Nations General Assembly as Special Rapporteur on the Immunity of State Officials from Foreign Criminal Jurisdiction. The report proposed to add aggression, slavery, and slave trade to topics that are not immune from foreign criminal jurisdiction. This proposal was approved by the International Law Commission, of which Claudio Grossman is also a member. The report reviews and responds to States' comments on the draft articles, proposing revisions and updates as part of the Commission's second reading of this long-running topic.



27th Annual Grotius Lecture

For 27 years, AUWCL has sponsored the Grotius Lecture as part of the opening of the Annual Meeting of the American Society of International Law. The 27th Grotius Lecture featured E. Tendayi Achiume, Stanford Law Professor and UN Special Rapporteur on Contemporary Forms of Racism, Racial Discrimination, Xenophobia and Related Intolerance, and distinguished discussant Jamil Dakwar, Director of the Human Rights Program at the ACLU. The lecture titled "Traditions and Transitions: For Whom is International Law?" discussed the use of the United Nations Human Rights mechanisms in addressing racial discrimination and xenophobia.

AUWCL faculty made a powerful impact at the 2025 ASIL Annual Meeting, with Professors Susan Franck serving as Annual Meeting Co-Chair, Rebecca Hamilton as Meeting Committee Member and Panel Organizer, and Padideh Ala'i as sponsor of the Grotius Lecture. Professors Claudio Grossman, Diane Orentlicher, and Janie Chuang each spoke as panelists throughout the event.

New Faculty Join AUWCL International Program



Professor Matthew Erie

Matthew Erie, specializing in Chinese Law, Law and Development, and International Business Law, brings a distinctive interdisciplinary voice to international and comparative legal scholarship, drawing on

his dual training in law and anthropology to examine how “non-liberal” legal orders interact with transnational norms. Erie’s work is situated at the intersection of comparative law, international economic order, and socio-legal theory, with a focus on China’s engagement with global legal norms.



Professor Jeffrey Kahn

Jeffrey Kahn, professor of law and the director of the Law & Government Program, specializes on the rule of law in Russia and the intersection of national security and constitutional governance. Kahn’s work on

U.S. constitutional law, comparative human rights, Russian law, and latest research on the influence of the Council of Europe in Russia draws from his experience at the U.S. Department of Justice and researching and advising on the Russian legal system.



Professor Sylvia Lu

Sylvia Lu’s work focuses on Comparative Law, Data Privacy Law, Torts, and Artificial Intelligence Law. Lu draws on comparative legal analysis to examine regulatory approaches to AI and data governance across

the U.S., EU, and Asia. Lu is a leading legal scholar in the fields of data privacy and artificial intelligence, developing proposals to address the challenges posed by data-driven technologies.



Professor Marcos Orellana

Marcos Orellana, the UN Special Rapporteur on Toxics and Human Rights, teaches international human rights, comparative, and environmental law. Orellana specializes in the role of global interests in shaping

and operationalizing global obligations, and the interface between human rights and the planetary environmental crisis. His teaching and scholarship draw upon his work with United Nations agencies, governments, non-governmental organizations, civil society, and international courts and tribunals.

New Leadership for Brazil-U.S. Legal and Judicial Studies Program



Gustavo Ribeiro, Brazilian lawyer and Associate Professor at AUWCL, has been named director of the Brazil-U.S. Legal and Judicial Studies Program. Ribeiro’s scholarship and work focus on evidence, civil procedure, and jurisprudence in Brazilian and American legal contexts. The Brazil-U.S. Legal and Judicial Studies Program offers participants including judges, academics, and legal professionals in both countries a firmer understanding of the Brazilian and American legal and judicial systems, exchanging practical knowledge as the U.S. and Brazil increase interaction in judicial and other collaborative areas.

Program Partnerships and Grants



Humphrey Fellowship Program:

Since 2002, AUWCL has hosted the Hubert H. Humphrey Fellowship Program, a Fulbright Exchange activity sponsored by the U.S. Department of State’s Bureau of Educational and Cultural

Affairs. Fellowships are awarded to mid-career professionals through a competitive selection process, providing them with a year-long opportunity for academic enrichment and professional development at prestigious institutions across the United States. Currently, AUWCL is the only law school that hosts Humphrey Fellows.



Partnership with ADA University School of Law (Baku, Azerbaijan):

AUWCL partners with ADA University School of Law in Baku, Azerbaijan to help build capacity in four areas

of the ADA Law School: legal research and writing, administrative law, experiential and clinical education, and establishment of a law library. In addition, during the 2024-2025 year, AUWCL welcomed the second cohort of LL.M. students in the program which was launched under the collaboration between AUWCL and ADA University.

Geneva Centre on Knowledge Excellence: The AUWCL Program on Information Justice and Intellectual Property (PIJIP) and the Geneva Graduate Institute launched the Geneva-based Centre on Knowledge Governance. The Centre grows out of PIJIP’s work promoting the public interest in international intellectual property law and builds on the existing memorandum of understanding between American University and the Geneva Graduate Institute to provide opportunities for student and scholar exchanges, support students participating in AUWCL’s long-standing summer abroad program in Geneva, co-host events and educational programs, and develop joint research projects.

AUWCL War Crimes Research Office: For 25 years, the AUWCL War Crimes Research Office (WCRO) has served as a resource for tribunals and other organizations promoting accountability for atrocity crimes at the international, regional, and domestic level while helping students build essential advocacy and legal skills in the fields of international criminal law and international justice. The WCRO engaged in a new partnership with C4ADS and the New America Foundation on a project designed to explore accountability options for violations committed by irregular armed groups.

The Hague Summer Program on International Criminal Law and International Approaches to Terrorism



Now in its 20th edition, the Hague Summer Program on International Criminal Law and International Approaches to Terrorism immerses students in the institutions shaping international justice through guest lectures by judges, practitioners and experts in these fields and site visits to courts such as the International Criminal Court and International Court of Justice. Students also benefit from a career panel, intercultural sessions at the Asser Institute and post-program research and networking opportunities.

Lawyering Peace Program:

The Lawyering Peace Class is a one-semester experiential learning program, offering students an opportunity to develop professional skills and substantively engage in peace negotiations, post-conflict constitution drafting, and transitional justice planning as young professionals. Lawyering Peace students will work on a semester-long research project, drafting client-ready memoranda or other legal documents on international legal issues for the Public International Law and Policy Group.



Skills-based competitions:

Students have the opportunity to participate in both domestic and international moot competitions related to World Trade Organization law, arbitration, Inter-American human rights system, public international law and more.

PROGRAM DESCRIPTIONS

Brazil-U.S. Legal and Judicial Studies Program

The Brazil-U.S. Legal and Judicial Studies Program at American University Washington College of Law is a comparative law program focused on Brazil and the United States and their respective legal and judicial institutions. Led by Brazilian lawyer and AUWCL Professor Gustavo Ribeiro, the program is unique in offering a direct comparison of Brazilian legal and judicial institutions with those of the United States. The program provides participants with a firmer understanding of both Brazilian and U.S. systems and imparts substantial practical knowledge as the two countries increase their interactions with one another. For nearly 10 years, the program has organized a comparative symposium for Brazilian judges. Most recently, it expanded to offer training to Argentinian judges, formalizing an agreement with the *Asociación Argentina de Justicia Constitucional*.

Center for Human Rights & Humanitarian Law

Established in 1990, the Center for Human Rights & Humanitarian Law underscores AUWCL's enduring commitment to international human rights and the rule of law. For more than three decades, the Center has shaped norms, aided faculty, human rights experts, and students, contributing significantly to resolving prominent human rights issues. Currently, the Center delves into the relationship between public finance and human rights, strategically advocates in high-impact cases within the Inter-American system, and emphasizes the nexus between human rights and climate change, alongside the implications of toxic substances.

Center on International Commercial Arbitration

Established in 2004 and directed by Professor Horacio A. Grigera Naón, the Center on International Commercial Arbitration hosts a four-week summer institute in Washington, DC, and two moot arbitration competitions in English and Spanish. The Center offers five online certificate programs specializing in commercial and investment arbitration. In 2024 and 2025, the Center partnered with the Inter-American Commercial Arbitration Commission for a hybrid practical seminar for 40+ arbitrators and counsel across Latin America. The Center conducts cutting-edge research on institutional arbitration rules, legislation, and international regulatory initiatives. For more than 20 years, it has positioned AUWCL as a leading institution in commercial and investment arbitration, drawing students from various legal backgrounds.

Academy on Human Rights and Humanitarian Law

The Academy on Human Rights and Humanitarian Law prioritizes practical approaches to these fields, offering multilingual programs like the prestigious LL.M. in International Human Rights and Humanitarian Law, the Summer Program of Advanced Studies on Human Rights and Humanitarian Law, and the Inter-American Human Rights Moot Court Competition. These initiatives foster global connections among human rights organizations, practitioners, and educators, offering students unparalleled experiential learning opportunities.

Trade, Investment and Development Program

Since 2014, the Trade, Investment and Development Program (TID) at AUWCL has invited exceptional practitioners and trade experts to both teach and conduct research. TID oversees the trade law curriculum, the LL.M. program in International Business and Trade Law, and hands-on opportunities for students, including the John H. Jackson Moot Court Competition on WTO Law. Emphasizing the interdisciplinary nature of

trade, TID highlights its connections with labor, the environment, gender, and intellectual property annually. Headed by Professor Padideh Ala'i, the program hosts the Symposium on International Trade with the Embassy of Brazil and the Wenger Lecture in International Trade.

Tech, Law & Security Program

The Tech, Law & Security Program (TLS) unites leading experts in three critical areas—Content Regulation in the Digital Age, Privacy, Transparency, and Security, and Cyber and Information Conflict. The program's work prioritizes emerging technologies, fundamental rights protection, and engagement across public, private, and international domains. Over the past three years, TLS has concentrated on groundbreaking research covering cross-border data flows, regulation, surveillance, and comprehensive content moderation. The program hosted prominent speakers through its At-the-Intersection speaker series, continued its "TechTalks" for the AU community, and organized the "Navigating Emerging Gaps and Seams" symposium, fostering meaningful discourse on international law.

Business Law Program

Led by Director David Snyder and Associate Director Gerard Comizio, the Business Law Program is a leading hub for business law education and research. The Program takes a proactive stance on the role of business lawyers in addressing sustainability and human rights within global supply chains. Professor Snyder leads a working group and a task force in the American Bar Association and is a principal author of model contracts. He also co-chairs a parallel European Working Group, meeting regularly with prominent legal professionals, regulators, legislators, and scholars from numerous EU countries. The Program recently launched the Digital Asset Law Project.

War Crimes Research Office

For more than 25 years, guided by AUWCL Professor Susana SáCouto, the War Crimes Research Office has served as a critical resource for international tribunals and organizations promoting accountability for atrocity crimes worldwide. Over the last 15 years, the Office has developed significant expertise and global recognition in gender and international criminal law.

Program on Information Justice and Intellectual Property

The Program on Information Justice and Intellectual Property at AUWCL is a renowned academic and research hub for intellectual property and information law. Its accomplished faculty covers all major aspects of the field, including Copyright, Patent, Trademark, Trade Secret, Cyberlaw, and international IP. PIJIP serves as a significant incubator of research and public discourse on public interest in global intellectual property policymaking. AUWCL boasts one of the oldest intellectual property programs in the world, with origins dating back to 1910.

U.S. and International Anti-Corruption Law Program

The U.S. and International Anti-Corruption Law Program provides peer-to-peer learning taught by leading experts and designed for public, private, and non-profit sector professionals from around the world to enhance their expertise and expand their anti-corruption networks and professional contacts. The Program offers a summer certificate on U.S. and International Anti-Corruption Law and custom-designed programs tailored to specific professional groups and topics, and organizes the Frank H. Menaker Jr. Corporate Integrity Lecture Series.
