William R. Fernekes (B. A., M. A., Ed. D., Rutgers University) taught social studies and Spanish from 1974-1987 at Hunterdon Central Regional HS in Flemington NJ, and then served as supervisor of social studies at Hunterdon Central from August 1987 to his retirement in December 2010. He received his doctorate in social studies education and curriculum in 1985, working under the tutelage of Jack L. Nelson, a leading scholar in social studies and issuescentered education. Co-author with Beverly C. Edmonds of Children's Rights: A Reference Handbook (Santa Barbara CA: ABC-CLIO: 1996), he has published widely in the fields of Holocaust and genocide studies, human rights education, and issues-centered social studies education. His 2002 publication for Greenwood Press of Westport CT, The Oryx Holocaust Sourcebook, was recognized as an outstanding reference book by Choice magazine. He has served as a consultant to the Education Department of the U.S. Holocaust Memorial Museum, the New Jersey Commission on Holocaust Education, and numerous other scholarly institutions. In Dec. 2011, he received the Mel Miller Award from the National Social Studies Supervisors Association as the outstanding social studies supervisor in the United States, and in March 2012, he received the Distinguished Service Award from the Rutgers Graduate School of Education Alumni Association. He is a founding member of Human Rights Educators-USA, and currently teaches courses in social studies methods, global education and human rights and education as a lecturer in the social studies education program at the Rutgers Graduate School of Education

Robert K. Goldman, Professor of Law American University Washington College of Law and Vice Chair of the International Commission of Jurist

Robert K. Goldman is Louis C. James Scholar; co-director, Center for Human Rights and Humanitarian Law; faculty director, the War Crimes Research Office; and professor of law. He holds expertise in international and human rights law; U.S. foreign policy; terrorism; and law of armed conflict. From 1996 to 2004 he was a member of the Organization of American States' Inter-American Commission on Human Rights, and its president in 1999. From July 2004 to July 2005, Goldman was the UN Human Rights Commission's Independent Expert on the protection of human rights and fundamental freedoms while countering terrorism. In October 2005, the International Commission of Jurists named him one of the eight jurists on the Eminent Jurists Panel on Terrorism, Counter-Terrorism and Human Rights. In 2008, Goldman was elected Commissioner and member of the Executive Committee of the International Commission of Jurists. He is author of The Protection of Human Rights: Past, Present and Future (1972); coauthor of Middle East Watch's book, Needless Deaths in the Gulf War, a 1991 publication that assessed civilian casualties during the 39-day air campaign and assigned responsibility for violations of the laws of war; and coauthor of The International Dimension of Human Rights: A Guide For Application in Domestic Law (2001). He is also the author of scores of reports, papers and articles on human rights and humanitarian law related issues.

<u>Claudio Grossman, Dean, American University Washington College of Law & the Raymond Geraldson</u> Scholar for International and Humanitarian Law; and Chair, United Nations Committee Against Torture

Claudio Grossman is Professor of Law and Dean of American University Washington College of Law (WCL) and the Raymond Geraldson Scholar for International and Humanitarian Law. Dean Grossman serves as Chairperson of the United Nations Committee against Torture (since April 2008), as a Committee member (elected in November 2003), and as chair of the ten United Nations Human Rights Treaty Bodies (elected in May 2013 for a one-year term). He is a member of numerous associations including the American Law Institute and the Inter-American Institute for Human Rights (IIHR), and in January 2014 was selected as the IIHR's President. He previously served as a member of the Inter-American Commission on Human Rights (1993-2001) and was twice elected its President (1996 and 2001). Dean Grossman has written many publications on international law and human rights, and has received numerous awards for his contributions to these fields and to legal education (*see* http://www.wcl.american.edu/dean/cv.cfm). He is graduate of the law school of the University of Chile and received a Doctor of the Science of Law (*Doctor in de Rechtsgeleerdheid*) from the University of Amsterdam.

Marissa Gutiérrez--Vicario, Harvard

Marissa brings over a decade of experience of working for social justice on the ground and around the world: she worked on a documentary film on labor rights in Mexico; volunteered for women's rights nonprofits in Guatemala and Senegal; and documenting minority rights abuses in India. In her adopted home of New York City, Marissa has worked with several non-profit organizations dedicated to youth development, community organization, and leadership building. As a graduate of the Harvard Graduate School of Education, Marissa has a master's degree in arts education. She has also received a master's degree in public administration from New York University and a bachelor's degree in political science and international relations from the University of Southern California

Hadar Harris, Professor of Law, American University Washington College of Law

Professor Hadar Harris is an International Human Rights attorney and specializes in issues of civil and political rights, gender equality, and domestic implementation of international norms. Since 2002, she has served as the executive director of the WCL Center for Human Rights & Humanitarian Law. As such, she is responsible for an annual program of 50-70 events and conferences, a variety of grant-funded programs and approximately 20 ongoing collaborative projects with students and NGOs around the world. These include current projects focused on the human rights of persons with disabilities, the integration of human rights approaches and legal arguments into the work of legal service providers (poverty lawyers) in the United States; follow-up and implementation of the work of

He was a Fulbright Scholar in the Republic of Colombia in 1987, and served as Legal Advisor to the Consulate of the Republic of Colombia in Washington during 1998. He has lived or consulted in several Latin American countries and has lectured or consulted in the United States, Eastern and Western Europe, and Asia. Professor Wilson has presented three cases at the Inter-American Court of Human Rights in San Jose, Costa Rica and authored the friend-of-court briefs for the European Union in the United States Supreme Court successfully arguing that international law prohibits capital punishment for juveniles and for persons with mental retardation. Prof. Wilson serves as President of the Board of Directors of the World Organization for Human Rights, U.S.A., and on the Board of Ensaaf, a human rights NGO with focus on impunity in India, particularly in Punjab. He is a co-editor of textbooks on international human rights law and practice; defense in international criminal law; and international criminal law and procedure. His scholarly interests include the globalization of public interest law, the death penalty and international law, the role of the defense in international war crimes trials, and clinical legal education in developing or transitional countries.
